Abdul Ali and (4) Prof (Dr) Fathimathu Zuhara, members of the Syndicate to propose the name of experts to be included in the Board of Studies in Criminology and Forensic Science. The Syndicate resolution was implemented , subject to approval of the Hon'ble Chancellor, vide reference read (2) above.

As per the reference read (3) above, the office of the Hon'ble Chancellor has clarified that approval of the Hon'ble Chancellor is not required for the implementation of the decision of the Syndicate held on 19.07.2014,18.08.2014, 08.10.2014 & 14.10.2014 (including the above Syndicate decision) except that of the disputed items, which attract section 10 (16) of the Calicut University Act, 1975.
