ORDER

The Syndicate at its meeting held on 19.07.2014, resolved to constitute the Boards of Studies in Criminology & Forensic Science and to start courses in these knowledge areas as per rules & regulations and constituted a sub committee of the Syndicate to propose the names of experts to be included in the Boards of Studies, vide reference read as (1) above. The sub committee has submitted its report to constitute seperate Boards of Studies (Single Boards) in Criminology under the Faculty of Social Science and Forensic Science under the Faculty of Science, along with proposed list of 11 members to each Boards of Studies. The Syndicate vide item No.2015.594 dated 05.05.2015, approved the sub committee report.

As per Statute 23 in Chapter 3 of Calicut University First Statute 1976, the maximum number of members to be included in a single Board is 10. Further there is no Faculty of Social Science in this University, and Social Science subjects are under the Faculty of Humanities.

As per the reference read as (2) above, the Syndicate at its meeting held on 06.06.2015, (vide item No. 2015.727*), authorised Sri. K. K. Syed Abid Hussain Thangal, Sri. K.M. Naseer and Sri.Salahudheen P.M, members of the Syndicate to limit the number of members in the proposed lists of members to the new Boards of Studies in Criminology and Forensic Science to 10 each and to confirm the Faculty in which the Board of Studies in Criminology is to be included. Accordingly the sub committee of the Syndicate has submitted the list of members to the Boards of Studies in Criminology and Forensic Science by excluding one member from each Board. The committee also suggested to include the Board of Studies in Criminology under the Faculty of Humanities.

The Syndicate vide reference read (3) above has approved the list of members to the Boards of Studies in Criminology & Forensic Science submitted by the sub committee and their suggestion to include the Board of Studies in Criminology under the Faculty of Humanites.
